Complaint of User Detection Faulty, unit is I/W - Toc stated via emailand invoice from office to HSM Environmental MP Report - Complaint of possible faulty user hinge however at time of visit unit was working correctly, apart from needing nozzle cleaner and carbon filter. As per pictures included with report the unit is directly in the shower area and disabled end user states that toilet gets absolutely soaking wet after every shower. End user states that loss of functions is intermittent and obviously occurs after the shower has been used. In my opinion the unit has been installed in the wrong place and this in turn us creating loss of functionality. Also the front cover has been completely sealed with mastic and an extra raised plinth has been put around the lower skirt and sealed in. 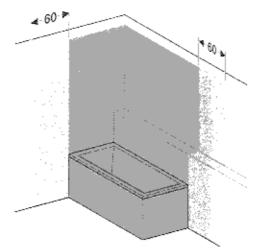

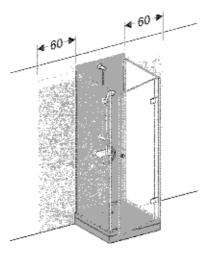

 The Geberit AquaClean models correspond to protection degree IPX4 and may only be installed outside of the edge of the tub or tray.

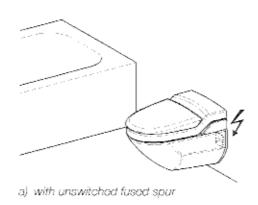


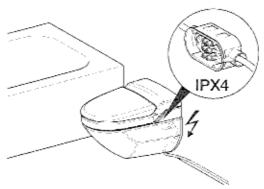
Protection area around the bath tub



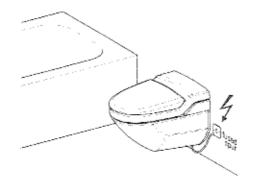
Protection area around the shower tray

1. Hidden connection

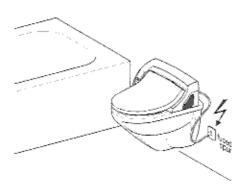




b) with fixed connection via junction box (at least IPX4, Geberit AquaClean may be closer than 60 cm to the edge of the tub or tray)



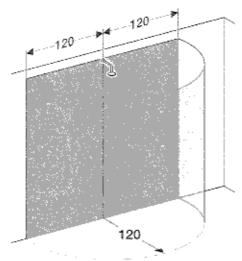
Geberit AquaClean complete solution



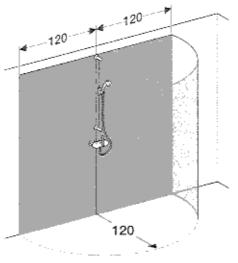
Geberit AquaClean enhancement solution

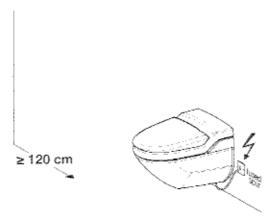

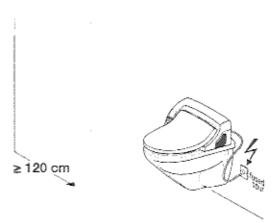
Protection area around the shower without tray (with fixed shower head)



Protection area around the shower without tray (with flexible hose)



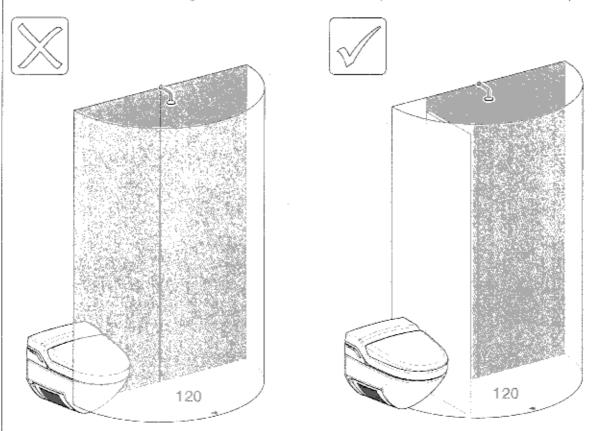

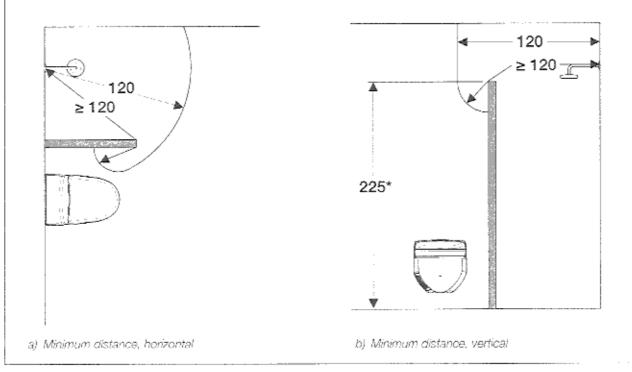
Geberit AquaClean enhancement solution

Geberit AquaClean in the protective area

Approach: Construct a fixed shower partition with a height of 225 cm between shower and WC system. This will mean that the WC system is outside the protective area. Non-conforming installation of the Geberit AquaClean models will then be possible.



* In the case of shower partitions with heights less than 225 cm, the minimum distance in horizontal (encompassing radius) and vertical (thread measure) direction must be maintained.



The Aquaclean cannot be installed directly under a shower

The Aquaclean 8000+CARE is IPX4 rated (splash protected) and safe to be installed in zone 2.

The power connection must be made outside of zone 2 and fixed to an un-switched fused spur 5amps
